## Respite is...

Planned or emergency care provided to a child or adult with special needs in order to provide temporary relief to family caregivers who are caring for that child or adult.

Lifespan Respite Care Act definition PL 109-442



#### 9STEPS TO RESPITE CARE for Grandfamilies

#### A Pathway to Get the Break You Deserve

If you are a grandparent or other relative caring for your grandchildren, nieces, nephews or other related children, you may be considered a "grandfamily." The relationship between grandparents and grandchildren is often a very special one. For a growing number of grandparents, grandparenting really means full-time parenting for a second family.

As a grandparent or family member providing care for your grandchild or another child in your family, you may engage in multiple roles in supporting their development and overall quality of life and that includes being a caregiver. You are called a caregiver if you provide care or support for a child in your family, whether you help full-time or as time permits. Typically, caregivers are parents. but can

include other family members, such as grandparents, aunts, uncles, or siblings who are providing care.

Undertaking the full-time responsibility for raising a grandchild or other relative causes major changes in one's life. This new role often includes physical, emotional, social, legal and financial challenges

▶ ▶ What is respite? Respite is a temporary break from caregiving responsibilities, from taking care of the children in your home so that you can get a break, enjoy yourself, connect with friends and other family members, take care of your health issues, recharge your batteries, or just rest.

that were not present when you raised your own children. Respite, a temporary break from the ongoing responsibilities of caregiving, can provide a much needed break from these responsibilities, giving time to balance caring for your grandchildren with caring for yourself.

Grandfamilies often face unique legal and financial challenges. Most grandparent and other relative caregivers step into the parenting role without legal custody or guardianship and may lack the necessary authority to consent to medical care, access education, or obtain larger, affordable housing to accommodate the new family members. The cost of raising children is also something that can cause a tremendous burden and financial

## Kinship Navigator

## Services as Usual & Case Management

#### **Services as Usual:**

- Information and Assistance Model funded by the state legislature since 2005.
- Kinship Navigators provide information, assistance, and support to caregivers raising their relatives' children both inside and outside of the formal child welfare system.

# KCSP and Tribal Kinship Navigator Programs

- KCSP funds are to provide durable goods for kinship caregivers who are not involved with the child welfare system. These funds can also be used for camps and youth activities.
- Tribal Kinship Navigator Program-seven of 39 federally recognized tribes in WA state partner with ALTSA to provide Tribal Kinship Navigator Program.
  - Seven participating tribes include-Lummi, Quileute, Makah, Port Gamble S'Klallam Tribe, Samish, Colville, and Yakama Nation

## **Tribal Respite Pilot Project**


#### Port Gamble S'Klallam Tribe

- Developed their own training with input from DSHS/ALTSA
- Train Tribal members to provide respite within their own community
- Lifespan Respite funds are provided respite vouchers.
- This fills a gap for the community as many of their existing respite resources have eligibility limitations, such as diagnosis, age of caregivers, etc.
- The pilot project is available to use as a templet for other interested Tribes.

## Other Respite Opportunities

## **Grandfamilies and Kinship Caregivers Respite Voucher Program**



- The VLRVP has expanded its program to provide reimbursements to Kinship Caregivers to take a break from caring for their loved one.
- The Kinship Caregiver Voucher Program is designed for grandparents or other blood relatives caring for a minor child(ren) for whom they have custody.
- There is no age limit associated with this program.
- The goal of this program is to enhance access and reduce barriers to respite care, as well as, enhance education and awareness about respite care.

## **Grandfamilies and Kinship Caregivers Respite Voucher Program**



- Respite funding is limited to \$595.00 per family through June 30, 2026, or until funds are exhausted.
- Virginia was able to expand to providing funding for Grandfamilies and Kinship caregivers from a supplement grant from ACL in 2023.
- Division for Aging Services administers the program, which began accepting application for the Grandfamilies and Kinship Program in February of 2024.

### **Positive Outcomes**



#### Family member reported:

- The funds provided an opportunity for the child(ren) otherwise they could not afford before.(camps, visits with family, etc.)
- Peace of mind and confidence.
- Relaxed and enjoyed moment of "silence".

#### Family reported the child(ren):

- Was able to go to facility to enjoy things they have not done before.
- Build trust with staff, and other responsible adults.
- Had Fun!!!

### Health Care Concerns Noted on application



- Currently 75% of the Grandfamilies and Kinship Caregivers are reporting Attention Deficit Hyperactivity Disorders, diagnosis in the child(ren) they are caring for.
- With many of the families providing Individual Educational Programs (IEP) indicating diagnosis with
  - Autism
  - Anxiety
  - Speech Delay
  - Complex PTSD
  - Fetal Alcoholism
  - Disruptive Mood Dysregulation Disorders
  - Oppositional Defiant Disorders

#### CAREGIVER SUPPORT SERVICES

Caregiver Support Services (CSS) offers comprehensive support to caregivers and their families to prevent child abuse and neglect. The program serves children between the ages of 0-13 who have physical disabilities. social-emotional challenges, or developmental delays/disabilities and their caregivers.

#### KIDS VILLAGE

Kids Village, offers two levels of residential care, including the Children At-Risk of Human Trafficking program. Services provided to children ages 4-17 include individual and group therapy, psychiatric treatment, nursing, Applied Behavior Management, recreation, educational support, and assistance with activities related to daily living skills.

#### SEEDS

SEEDS is a multidisciplinary intervention program that works collaboratively with schools, family members, and the community to ensure children are ready for Kindergarten, promoted at the end of the school year, and reading on level by third grade in Hillsborough County.

#### **FOSTERING** FAMILIES

Fostering Families is committed to recruiting, preparing, and supporting foster families and to nurturing children and mentor families as a whole, striving to keep siblings together, while providing safety and permanency through reunification and family restoration.

#### KINSHIP / FAMILY FINDING

These programs support and seek out grandparents, relatives and nonrelative caregivers caring for children full time through Kinship Navigation and Emotional Support Services, early childhood education, tutoring, support groups and promoting self-care practices and programming throughout Central and South Florida and offer consultation & training across the country.

#### **PINELLAS** SUPPORT TEAM

PST provides behavioral modification. individual and family counseling, and tutoring services to families residing in Pinellas County, PST Staff work closely with the schools in Pinellas County to identify students in pre-kindergartenhigh school who are experiencing difficulties due to behavioral or emotional issues impacting their academic success.

#### **HEALTHY FAMILIES** HILLSBOROUGH

This nationally accredited home visiting program for expectant parents and parents of newborns experiencing stressful life situations improves childhood outcomes and increases family self-sufficiency by empowering parents through education and community support.

#### REACHING AND INSPIRING STUDENTS EVERYWHERE (RAISE)

RAISE works with families of children with a diagnosed disability, children with possible developmental delays, and children displaying disruptive or concerning behavior. RAISE services include collaboration with schools and the community to ensure children birth through 3rd grade and their families receive individualized services designed to meet their needs, and promote positive behavioral, developmental and educational outcomes.

## What is Caregiver Support Services?

 A <u>respite</u> and <u>wraparound</u> service with an overarching goal to <u>reduce and</u> <u>eliminate the incidence of abuse and neglect</u> and placement of children into foster care in the Tampa Bay Area of Central Florida

#### CSS:

- 1. Places an emphasis on family choice and voice
- 2. Assists the family in reducing stress by increasing access to community supports and resources
- 3. Offers time limited respite services in a variety of settings
- 4. Assists in the development of an informal system for long-term sustainability, and provision of open-ended, long-term support through support groups

## Eligibility Criteria

We provide services to any parent or caregiver caring fulltime for a child 0-13 and living in the Tampa Bay area

#### The child may have a:

- Physical disability
- Social-emotional challenges
- Developmental delays/disability

Or a Caregiver may be experiencing an acute situational stress leading to a strained family system.

The child may have an underlying medical condition but deemed "medically stable" and not requiring medical care during respite services.

## The Benefits of Caregiver Support Services

- Improve caregiver/child and sibling relationships
- Reduce Parent and Caregiver stress
- Focus on personal and family goals
- Helps families stay healthy and their children reach their full potential.

- Provides the tools and resources for our Navigators and Respite Caregivers to offer the knowledge, empathy, and guidance to parents and caregivers.
- We offer a nurturing experience for those in need of respite care.
- CSS trains and produces quality Caregivers!

## What are wraparound services:

- An approach that considers the **whole** family unit, not simply the identified child or caregiver, knowing the family unit is a highly integrated, complex system that must be addressed holistically.
- A thorough assessment that includes a determination if the family/child has medical insurance, stable housing, free or reduced school lunch, and other risk factors in addition to assessing protective factors, strengths, and challenges.
- Connects families with needed resources to build and expand the family's support systems.
- Offers monthly Support Groups for long-term sustainability.
- Provides Parent/Caregiver education

## Types of Respite being offered:

#### 1. <u>Family-Selected caregivers</u>

-selected by the family, assumed to have knowledge of the family, knows the child, and understands the culture and habits of the family. \*CSS places great value on family selected caregivers as this respite option has the greatest probability of sustainability as a long-term support for the family. Overnight care may be provided through this stipend-based option.

#### 2. Respite care providers

-PT and FT employees of CHN

#### 3. Center Based Care

-will be used when the family's choice is to have the child go off site to receive the respite relief. CSS will offer a financial payment for the center care based on the level of care and authorized hours in the service plan.

#### 4. Group Care

-shelter care provided to children that have an immediate need to leave their family setting for a brief period of time allowing the family to secure services, have a cool down period and plan for the reunification.
